

Chair Moore called the meeting of the Laguna Woods Civic Support Fund Board of Directors to order at 3:03 p.m.

Moved by Vice Chair Rothberg, seconded by Director Tao, and carried unanimously on a 4-0 vote with Director Tung absent, to approve the Board of Directors meeting minutes for the meetings on March 2, 2021 and April 6, 2021.

10. BOARD OF DIRECTORS COMMENTS AND ANNOUNCEMENTS – None

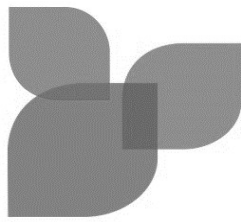
